5. Councillor Announcements

A Bruni reminded GSA Councillors that internships were offered through the Graduate Student Internship Program and that there was currently a public service graduate internship available; one year in length or 42 weeks split in to two 21-week rotations in various levels of government. He added that this position was open to any student interested in public policy and that the deadline to apply was in January. In addition, he indicated that the position of Project Manager for the Graduate Student Internship Program was available and that the competition closed on October 1.

S van der Klein informed GSA Councillors about the Canada 150 Community Celebration on Sunday, September 24 at South Campus. She noted that there was a limited parking and invited members to take transit if there were planning to attend. She added that there would be food trucks, a farmers market, and live performances.

Action Items

6. Proposed Changes to GSA Policy on Nominating and GSA Nominating Committee

Babak Soltannia (GSA President and GSA Governance Committee Chair) and Radim Barta (GSA Nominating Committee Chair) presented the item.

MOTION BEFORE COUNCIL: That the GSA Council, on the recommendation of the GSA Governance Committee, **APPROVE** the proposed changes to GSA Policy on Nominating and the GSA Nominating Committee, as shown in the attached double column documents and effective immediately.

B Soltannia noted that GSA Council had before them proposed changes to GSA Policy on Nominating and the GSA Nominating Committee. He noted that the GSA Policy on Nominating was first established by GSA Council in 2010 and had not been thoroughly reviewed since that time and, while GSA Policy on the GSA Nominating Committee had been reviewed in the past year, the GSA Nominating Committee (GSA NoC) and GSA Governance Committee (GSA GC) were now recommending further amendments. B Soltannia invited R Barta to provide an overview of the proposed changes and to answer questions.

R Barta introduced himself as Chair of the GSA NoC and noted the other members of the GSA NoC who were present at GSA Council (A Bruni and K Gordon). He noted that the proposal before GSA Council resulted from discussions during a GSA NoC meeting on July 17, and that these proposed changes were reviewed by the GSA GC on August 15 and by the GSA Board on August 23. He reported that the substantive changes included rewording of the policy to reflect current practice, expanding the number of positions on the GSA NoC that were open to all graduate students instead of just GSA Council members, and formalizing the current practice whereby GSA Council elected all representatives for GSA Standing Committees instead of having the GSA Council ratify nominees that the GSA NoC elected for these positions. R Barta also indicated that while the GSA NoC would continue to vet all nominees brought forward to GSA Council to ensure they met the eligibility criteria outlined in GSA Bylaw and Policy, it would be GSA Council's role to elect the best nominees for these positions. He noted another change was the removal of the call for additional nominations for GSA Standing Committees, ad hoc committees, and subcommittees,

and GSA Council-Elected Officer positions. He indicated that the call for additional nominations was currently restricted to only GSA Council members and that the proposed policy change would allow for one nominating period that would be open to all eligible graduate students. He emphasized that in order to allow enough time for nominees to put their name forward, each position would still be advertised at least twice. He also noted that while there were currently five voting positions on the GSA NoC, with three positions specified for GSA Council members, and two positions for any graduate student, the proposal outlined that there would now be at least two GSA Council positions and three positions for any graduate students. R Barta noted this would allow for more flexibility in recruiting members to serve on the GSA NoC, and that as the NoC was focused on selecting excellent graduate students to fill vacancies across campus, it would be beneficial to have more graduate students at large serving on the GSA NoC.

A Tawiah asked what the original rationale was for having three GSA Council members and two graduate students on the GSA NoC. R Barta responded that since the GSA NoC was originally created to act on behalf of GSA Council to elect graduate students to serve on external committees, its membership first included three GSA Councillors, the GSA President, and the GSA Executive Director (ED). He indicated that as time went on and the GSA NoC became more established, the GSA President and GSA ED became non-voting members and the membership was expanded to include two graduate student members. R Barta noted that since the GSA NoC represents GSA Council in filling graduate student positions on external committees across the University that it made sense to have more graduate student members from across campus.

F Jean asked whether the new requirement to advertise positions twice would lead to delays in the nominating process. R Barta responded that advertising positions at least twice wouldn't increase the timelines, since currently there was already a first call and a second call. He noted that right now the second call for nominations was only sent to GSA Councillors, so the proposed changes would combine these two nominations periods into a single one open to all graduate students. He noted that positions open to GSA Council members would continue to only be advertised to GSA Council. He noted that it was important to allow for enough time to make sure everyone had an equal chance to put their name forward.

A Tawiah asked what the response rate was for getting graduate students to put their names forward to serve on GSA Standing Committees, and with the second call for nominations being sent to only GSA Councillors, if there was difficulty in getting students to fill those roles. He also asked if only GSA Councillors came forward following the second call for nominations. R Barta responded that if the first call for nominations had a low response rate, that the second call for nominations would also normally have a low response rate. He noted that sometimes GSA Councillors would nominate themselves after the second call for nominations, and hoped that GSA Councillors would continue to volunteer for positions. He noted that the GSA NoC would continue to inform GSA Council about all of the available positions and asked GSA Councillors to encourage their colleagues to volunteer. He noted that there were a number of ballots for this Council meeting and that it was harder to fill positions during the summer months.

MOTION: That the GSA Council, on the recommendation of the GSA Governance Committee, **APPROVE** the proposed changes to GSA Policy on Nominating and the GSA Nominating Committee, as shown in the attached double column documents and effective immediately. BS **MOVED.** FK **SECONDED**.

8. President

i. President's Report:

Members had before them a written report, which had been previously distributed on 15 September 2017. The report stood as submitted. In addition B Soltannia welcomed everyone to a new academic year and invited GSA Councillors to come to the GSA coffee break on September 29 and to attend the GSA Fall Social Event on October 12.

A Tawiah asked for a summary of the discussion he had with the Dean of the Faculty of Graduate Students and Research and the Provost and Vice-President (Academic) about the funding review proposal mentioned in B Soltannia's report. B Soltannia responded that the funding review proposal was still in early stages and that there were no major updates to report on. F Khodayari added that negotiations have started between the GSA, Dean of the Faculty of Graduate Students and Research, and the Provost and Vice-President (Academic) but that these negotiations could take a long time. He added that as soon as there were developments GSA Council would be updated.

In addition F Khodayari reminded GSA Councillors of the Professional Development requirements and noted that the restriction on having no more than four hours in any one area had been lifted, which would allow for greater flexibility. He invited GSA Coucillors to visit the FGSR website for more details.

10. Vice-President External

Members had before them a written report, which had been previously distributed on 15 September 2017. The report stood as submitted. In addition M Khademi highlighted that in the past few months he had been engaged in discussions about Student Group policies with the Dean of Students Office and he invited GSA Councillors to provide feedback. He specified that any feedback would be submitted to the Dean of Students.

M Kiese asked if there was a particular reason to update these policies. M Khademi explained that the movement started from the Students' Union and they had concerns that these policies were not as effective as they could be. He added that some of these discussions go back a certain number of years but that the current Dean of Students had taken the issue on to review and update the policies. M Kiese pointed out that there were many references to the University reputation and asked if this was of particular concern. M Khademi responded that the concern was not specific but that they were trying to redefine "reputation" to make it easier for students to understand what that risk meant for the University.

11. Vice-President Labour

i. Vice-President Labour's Report

Members had before them a written report, which had been previously distributed on 15 September 2017. The report stood as submitted. In addition S van der Klein reminded GSA Council that the GSA was about to enter negotiations for the Collective Agreement. She noted that the GSA was holding a town hall on September 26 at 10:00 AM in the FGSR Boardroom in Triffo Hall and she invited students with assistantships to attend. Alternately, she invited student assistants to submit feedback by sending an email to S van der Klein at gsa.vplabour@ualberta.ca

S van der Klein noted that, over the last year, she had worked to create the Manage Up Speaker Series with FGSR, a workshop series with different themes. She specified that four dates were planned for the fall term and invited GSA Council to consult the FGSR website for additional details. She added that each workshop was one hour and would count toward Professional Development hours.

A Harrigan asked if the town hall was only for currently employed graduate students. S van der Klein responded that the GSA welcomed all but that, during collective bargaining, the GSA was required to act on behalf of the bargaining unit, which means currently employed graduate students (Graduate Teaching Assistant, Graduate Research Assistant (GRA), Graduate Research Assistant Fellowship (GRAF) or graduate students with short term academic employment).

M Armstrong asked for clarification of the difference between a GRA and a GRAF. S van der Klein explained that all graduate students paid by their supervisor to work on their own thesis research used to be classified as a Research Assistant (RA) but that in the last round of collective bargaining RA and students working on their thesis research had been separated, the latter one becoming GRAF. She added that for GRA positions there was a minimum level of payment outlined the Collective Agreement

and that for GRAF positions there was no minimum payment attached to it. She specified that GRAFs were also academicallyemployed and the conditions of their appointment was outlined in the Collective Agreement.

C Labonté asked if there would be additional Town Halls or if this was the only one. S van der Klein responded that this was the only one but that she was happy to met in person or encouraged members to send feedback via emails.

Dear GSA Council Colleagues,

13 October 2017

The attached double column proposals before you for consideration relate to recommended changes to GSA Bylaw and Policy on the Legal Defence Fund (LDF) and Budget Principles, Practices, and Procedures (with corresponding recommended revisions to the terms of reference of the GSA Budget and Finance Committee (GSA BFC)). These proposals were developed on the recommendation of the GSA's Financial Team and have been previously reviewed and discussed by the GSA BFC and the GSA Board (GSAB), as noted in the attached Outline of Issue associated with this item.

- The recommended changes contained within this proposal are a part of the GSA's ongoing effort to review all sections of GSA
 Bylaw and Policy to ensure they are up-to-date and align with established GSA practice. The recommended changes, not including various editorial updates, can be summarized as follows:
- Amending references to the generation and review of "quarterly reports on revenues and expenses" to "regular reports on revenues and expenses," with "regular" defined as at least three times per year. While the GSA will continue its adherence to standard accounting practices in terms of the GSA BFC, the GSAB, and GSA Council regularly reviewing its financial position, quarterly financial reports currently don't span exact quarters, per se. In practice, reports on expenses and revenue have gone forward to GSA Council in July (along with the audit), November, and February (along with the budget). These proposed changes will thus align GSA Bylaw and Policy with current practice.
- Amending the section addressing the size of the Financial Stabilization Fund, removing references to the reallocation of these funds, and adding references to the other restricted funds of the GSA. These proposed changes reflect current practice, which itself adheres to best practices with respect to financial management, wherein, instead of establishing a specific amount for the Financial Stabilization Fund, the GSA's Auditor makes an annual recommendation on the amount that should be included in this fund. They also more accurately reflect the purpose of the Financial Stabilization Fund and the circumstances under which it can be accessed.
- o Updating bylaw and policy on the LDF to align with the structure of that on the GSA Health and Dental Plan Reserve Fund.
- o Clarifying the circumstances in which the LDF may be utilized, as well as the means by which it may be accessed.

I look forward to presenting these changes to you at the October meeting of GSA Council and welcome any questions you may have. My thanks as well to the members of the GSA Financial Team and the GSA BFC for their attention to these proposed changes.

Information regarding the position for two (2) GSA Council members was circulated on two instances via email to GSA Council with a deadline of October 18, 2017. No nominations were received, so these vacancies will be advertised again. The one (1) position for a graduate student was advertised at least twice starting with the September 29, 2017 GSA newsletter with a nomination deadline of October 17, 2017. One (1) nomination was received. The nominee was then interviewed by GSA NoC Chair Radim Barta and GSA NoC Vice-Chair Kenzie Gordon, both of whom have been trained in procedural fairness by the GSA and have a record of demonstrating impartiality through their work on the GSA NoC. GSA Assistant Director Lisa Hareuther was also present. During the interview, the nominee was asked a series of questions aimed at assessing his awareness of the basic tenets of procedural fairness and his ability to adjudicate potential cases in accord with those tenets (note as well that all individuals elected to the GSA ACB receive training in procedural fairness).

Dear GSA Council Colleagues,

As many of you will remember, my team and I began the development of the 2017-2018 Board Strategic Work Plan (SWP) in May and we presented the finalized plan to GSA Council in July. The complete SWP is available for your review on the GSA website at http://www.gsa.ualberta.ca/SWP.aspx.

Below is an update concerning the GSA's progress in pursuing the strategic goals outlined in the SWP. Updates will also be provided to GSA Council in January and, before the end of our term of office, in April. I welcome the chance to discuss these updates with you on October 23 and also encourage you to ask questions about the status of the SWP goals at any time throughout the year.

Highlights from our progress include:

- One of our main team goals was to advocate for the University to launch a review of the current state of graduate student funding on campus. After submitting a proposal to the Provost and the Dean of the Faculty of Graduate Studies and Research (FGSR) concerning this, I have been continuing conversations with both parties about this key issue. We believe that such a review would constitute the first step in investigating the feasibility of the creation of minimum funding packages for graduate students, something of great importance because, for many graduate students, a lack of funding is a barrier to their academic success.
- Key goals from the Vice-President Labour's portfolio included negotiating for increased compensation for graduate student assistants in the Collective Agreement and ensuring the GSA's compliance with Bill 7. In July and August, the GSA hosted two Bill 7 Town Halls to discuss changes to labour legislation with attendees. The GSA Labour Relations Committee also met over the summer to start developing the GSA's initial Opening Position for bargaining with the University's Board of Governors (all current graduate student assistants will be asked to vote on the elements that will be included in the Opening Position before it is submitted). Sasha also hosted a Pre-Bargaining Town Hall on September 26, 2017 and eight graduate students attended; the GSA Negotiating Committee will discuss the feedback and suggestions received during this Town Hall as they develop the GSA's Opening Position.
- The GSA VP Student Services has continued working to support the Campus Food Bank in its mission to ensure the delivery of food for students in need, and their families. The Campus Food Bank Executive Director and Board Chair attended the GSA Board in September to provide updates on usage and their audited financial statements. In general, they continue to see an increase in usage. The GSA also collected donations for the Campus Food Bank at our fall engagement event on October 12.
- Our SWP outlines that we will "provide events throughout the academic year to support social engagement and reduce stress amongst graduate students." Starting in September, the DEOs continue to host a series of Coffee Breaks. These are informal events to get students out of their labs and offices to interact with other graduate students from across campus. The next Coffee Break is on October 27. Additionally, the GSA hosted its fall engagement event on October 12. This was a great opportunity to engage with graduate students and to provide them with a break from their studies in an informal and fun setting.
- Nursing students completing their practicum at Michener Park approached the Vice-President External and the Vice-President Student Services over the summer to communicate that residents continue to struggle with lengthy commute



times to campus through public transit. The GSA is continuing conversations with these Nursing students to develop a survey to learn about the transit usage of graduate students living in Michener Park. Moving forward, Masoud and Royle will be able to utilize the data collected in conversations with University administration to advocate for the establishment of a shuttle between Michener Park and the University.

- The SWP outlines that we will support workshops and services that assist graduate students with academic progress and professional development opportunities. Beginning in September, the GSA started sponsoring mini 20-minute writing sessions offered by the Student Success Centre to assist graduate students with the writing process. This new resource is open to all graduate students. Firouz, as the GSA VP Academic, has also been working with the FGSR and graduate students to gather feedback on available programs, including the Graduate Student Internship Program (GSIP) and the mentorship program. As part of this work, he has invited program coordinators from the FGSR to the October GSA Council to gather more feedback from students about these professional development opportunities.
- We had included in our SWP that we would discuss, with the FGSR, the possibility of revising FGSR policies concerning course-related examinations, including the ability to retake examinations and amend transcripts accordingly. After researching exam policies at other universities, we determined that this approach is likely not feasible, as we have not been able to find another university that allows graduate students to re-take exams. Firouz will continue to examine other ways to increase flexibility and improve communications with respect to course-related examinations and assignments in the interests of promoting enhanced mental wellness and career outcomes for graduate students. Firouz has also been working closely with the FGSR to improve communications regarding international graduate student involvement in the Graduate Student Internship Program.
- Ab-GPAC (the provincial advocacy group of which we are a member) issued an open letter reaffirming its stance on advocating for the inclusion of international student tuition fees in the province's Tuition Fees Regulation. The open letter can be viewed here. We anticipate that the Government of Alberta, following on its recent review, will soon be announcing its decisions regarding post-secondary tuition and funding.
- Sasha continues to participate in meetings to discuss the expansion of mental wellness resources at the U of A and the Homeless Student Campus Project Team to review current services that are available to homeless students and creating awareness about this issue in order to brainstorm potential short-term and medium-term solutions. On September 20, Sasha also hosted a GSA booth at the ACCESS Open Minds launch event. ACCESS is a national research and evaluation network that marks a major Canadian innovation in youth mental health service design, delivery, evaluation, and research.

On September 26, University of Alberta President David Turpin provided updates on the University's strategic plan *For the Public Good* at the 2017 State of the University Address. Updates were provided regarding the main pillars of the University's strategic plan: Build, Experience, Excel, Engage, and Sustain. On October 12, the GSA hosted, as also reported by Royle, its Fall Social Event, and graduate students, Senate members, and the Dean and Vice-Dean of the Faculty of Graduate Studies and Research joined us for icebreakers, games, mingling, and refreshments. The aim of this event was to encourage invitees to take a break from their studies while talking about their experiences, forging connections, and discovering the exciting work underway in the University's labs and classrooms.

Also, the GSA is excited to announce that we have partnered with the Student Success Centre to provide 20-minute writing sessions with two different graduate writing instructors. This resource is open to graduate students in any discipline and works to assist graduate students experiencing writer's block or other difficulties. Graduate students are able to sign up for these drop-in sessions on Tuesdays between 10 AM - 11:30 AM and Thursdays between 2:30 - 4:00 PM. More information can be found on our website.

The Alberta Graduate Provincial Advocacy Council (ab-GPAC), of which I am the Vice-Chair, has published its 2017 Advocacy Priorities. This document can be found on the ab-GPAC website: https://sites.google.com/view/ab-gpac/advocacy. Also, ab-GPAC produced an open letter to the government of Alberta on the future of tuition in Alberta https://sites.google.com/view/ab-gpac/news, and currently, as Masoud also reports, is working on another open letter to the government, emphasizing the necessity and benefits of the government's funding of Professional Development activities and advocating for the continuation of this funding. I am also working to as part of the ab-GPAC Governance Committee on a project to review their bylaws and policies.

With respect to our proposal to begin a review of minimum funding, FGSR has started a survey to acquire information and statistics on different questions, and to-date has received submissions from 40 different departments and expects these numbers to increase. I will continue to advocate for the potential creation of minimum funding packages, with this review being the first step.

Very recently Sasha and I also met with representatives of the Aboriginal Student Council to learn about their experience and work and to explore potential avenues of collaboration.

We will soon start our annual Early Call for Talent and Training program. Each year, as per GSA Policy, the GSA Nominating Committee is charged with the responsibility of actively seeking out graduate students for the positions of GSA President, Vice-President Academic, Vice-President Labour, Vice-President Student Services, and Vice-President External. The Early Call for Talent and Training program is designed to provide training and information to students considering running for elected officer positions and it will kick off with a Get-to-Know Dinner on October 25, 2017.

Finally, we also continue to host monthly GSA Coffee Breaks and I encourage you to attend the events! Our next Coffee Break will be held Friday October 27 from 1:00 – 2:30 PM in Triffo Hall.

It is hard to believe we reached the middle of our term so fast. I'm looking forward to the next 6 months and our work to continue implementing our Board Strategic Work Plan, and taking positive steps towards achieving our long-term goals to elevate the graduate students' experience on campus, and to alleviate their concerns and issues.

Dear Council Colleagues,

At its last meeting, GSA Council approved changes to the GSA Policy on Nominating. One of the changes included removing the additional call for nominations being sent to only GSA Council members for positions on GSA Standing Committees, and hoc committees, and subcommittees, and GSA Council-Elected Officer positions, in favor of allowing all graduate students access to all advertisements by requiring that these vacancies must be advertised at least twice in advance of the nomination deadline noted in the advertisement.

Upon reviewing other section of GSA Bylaw and Policy (Section D: GSA Officers, GSA Bylaw, GSA Officers; Section H: Performance, Conducts, Responsibilities, and Attendance, and the GSA Appeals and Complaints Board; and Section I: GSA Elections, GSA Policy, Elections), it was noted that these sections required factual changes to align with the removal of the additional call for nominations. Additionally, Section F: GSA Standing Committee, GSA Policy, GSA Standing Committees required a factual change to reflect that the GSA Policy on Nominating now specifies that GSA Council elects all graduate student members to fill vacancies on subcommittees, unless otherwise noted. As per GSA Bylaw and Policy, the GSA Governance Committee unanimously approved these editorial changes, via email, on October 10, 2017.

GSA Vice-President Academic Report to GSA Council for the October 23, 2017 Meeting

Dear Council Colleagues,

For those of you who are taking courses, I wish you luck with your midterms. As Vice-President Academic, I have attended several meetings and been involved with various discussions during the last month; I share the highlights with you in this report.

Compute Canada (CC)

Compute Canada has some resources for graduate students, which can be of a great value for those who need large computation/storage resources. Graduate students can have an account under their supervisor's (or principal instructor's) account to get free storage and use the Compute Canada computation facilities. If you want to review the details of this resource and/or talk to your supervisor, here is the website: https://www.computecanada.ca/

The University Aquatic Facility

As some of you might already know, many organisms recently died in the University's Aquatic Facility due to technical problems. The Dean of Science has given \$2.2 million for the clean-up and the improvement of the facility. Based on the response that the Office of the Vice-President (Research) provided to the Canadian Council on Animal Care (CCAC), they gave the University permission to start having organisms in the facility again; CCAC will be back at a later date for another visit. Almost all faculties use the facility, so it is critical to the University. Many students have been impacted because their research is dependent on the facility. If the current improvements take longer than anticipated, the University will help affected students in resolving issues (there are a smaller aquatic facility at MacEwan University and another one in Calgary, which could be used to help these students).

An Update on the Future Energy Systems

Last September, the U of A received a \$75 million federal grant to create Future Energy Systems. This project's main goal is to, in a multidisciplinary team, study what will our energy look like in the future. This is an important project, as many graduate students will be involved. Here are some details on this multidisciplinary project:

- Currently, 4 strategic areas are defined with specific themes under each, working on 40 projects spread across 6 faculties: Engineering, Science, ALES, Business, Arts, and Native Studies; in total 15 department are involved.
- The faculty members who are involved have many of research experience behind them.
- 2 years of guaranteed funding for faculty members with the completion of reports annually.

• The good news is that, as currently outlined, this project may hire many graduate students (PhD and Masters students) over the 7 years funding.

Government Tuition and Funding Reviews

We are expecting to hear about the results from the tuition and funding reviews from the government before Christmas. I will talk more about this in the upcoming months as we learn more.

The University's New Budget Model

The Offices of the Provost and of the Vice-President (Finance and Administration) are working on developing a new budget model for the University. The new model will be based on academic priorities and transparency. Revenues generated by each faculty will be visible in this new model. It is anticipated that it will distinguish between teaching and research activities. It is tried to move towards something that is more predictable, transparent, and based on teaching and research activities. Right now, the budget is developed on a one year basis, which is not ideal. The University's goal is to move towards a longer-term budget (potentially a three-year model).

I am happy to answer any questions or comments that you might have regarding this report. Also, I would be more than happy if you would like to share your suggestions or concerns regarding any academic related issue you have encountered at the University.

I hope you are doing well in all aspects of your lives. For those of you who still have some midterm exams to take, I wish you luck. This past month was a busy one for my portfolio. This report highlights some of the important updates in the meetings that I have attended.

During the past month, Babak and I attended two Alberta Graduate Provincial Advocacy Council (ab-GPAC) meetings. During one of the meetings we discussed the budget of the organisation and amended part of the Bylaw with respect to the timing of the AGM. In the other meeting, we discussed the communication strategies for the organization. In addition, the Dean of Students Office representatives shared their final draft of the student groups' policy with the members and asked for their feedback.

The Residence Budget Advisory Committee (RBAC) had two meetings this past month, in which representatives from Ancillary Services gave presentations about different aspects of their unit in terms of their operations and programing.

During the Alumni Student Council meeting, we discussed the adjudication process for the grant applications that we have already received. As this committee has several new members, a couple of adjudication training sessions were held for those new members to become familiar with the whole process.

The last meeting that I wanted to talk about is the Grand Council of Elders, which I was invited to attend as a member of Alumni Council. In this meeting, more than twenty indigenous alumni (who graduated between 1960 to 1980) were invited back to campus to share their wisdom knowledge with the University administration. A reception and alumni storytelling event followed this meeting. I really have to say, all of the stories and speeches were touching and thought-provoking.

In the next few day, before the GSA council, I am attending some other meetings, such as the Alumni Student Council, and a meeting with University of Alberta International (UAI).

For those of you that are currently employed as graduate assistants, you will have received the first GSA Labour update about the bargaining process and Bill 7, which included the link to a PowerPoint presentation from the September 26 Pre-Bargaining Town Hall, and an info sheet on what's currently on the go. Please let me know if you have any questions regarding the content, and I would be more then happy to answer them! I have found so far that our bargaining body is extremely diverse and opinions about labour related matters range over the complete spectrum of possible opinions, so it will be hard to distill a 'one-size-fits all' approach. However, I am determined to successfully complete this task and find a good balance in the negotiation process.

During the last month, I have been working on several cases including labour circumstances and supervisor issues. Unfortunately, progress in these cases is always slow. As per the Graduate Assistantship Collective Agreement, resolving conflicts always starts with an informal process, and it is only when these routes fail that official action is taken.

Another update is that Faculty of Graduate Studies and Research (FGSR) is starting a graduate student Parent Link. The details are not completely finalized yet, but it will start running alongside the Office of the Dean of Students Student Parent Project. The FGSR Parent Link will meet monthly for now and aims to help student parents build the skills, knowledge, and mindset that will support their scholarly journey, transition into the workplace, and foster health and well-being. GSA Vice-President Student Services Report to GSA Council for the October 23, 2017 Meeting

Time flies. I am passing the half-way point of my term as the GSA VP Student Services; I have learned many things and there is more to learn ahead. Your help and support has greatly aided my progress on initiatives related to student services and, over the next six months, I hope we can cooperate more so that we can contribute more for graduate students. I was mainly involved in the following activities during this busy October:

In order to help address the Michener Park transit issue, and as outlined in Masoud's report, Masoud and I met with Nursing students and the President of the Michener Park Residents Association. During this meeting, a draft survey was developed to collect data on transit usage at Michener Park. We provided editorial suggestions and discussed potential barriers to residents filling out this survey. The GSA was informed that after the survey questions are finalized, the Nursing students will run a pilot to test the survey questions and to see how the survey distribution process works. As noted below, I shared during the U-Pass Advisory Committee meeting that transit continues to be an issue for Michener Park residents.

In terms of the U-Pass Advisory Committee meeting, I provided an update on the Michener Park transit issue, noting that Nursing students completing their practicum at Michener Park had approached the GSA and indicated that they had heard significant feedback from residents that transit continues to be an issue and that residents are not happy with the timing of the routes. Meanwhile, the new updates to the Smart Fare project were also discussed during this meeting. It was noted that the design stage was the critical phase for the University and that ETS will be engaging with post-secondary institutions on this project to develop the new Smart Fare cards.

During the General Faculties Council Facilities Development Committee meeting two main issues, the General Space Program of the Information Services and Technology (IST) and the Augustana Campus Long Range Development Plan Amendments, were discussed effectively and constructively.

During our the monthly meetings with the Dean of Students, I continued to follow up on updates about the mental health budget and the music room program, which I mentioned during my July Council report. After meeting with Kevin Friese, the Assistant Dean of Students, Health and Wellness Services, to discuss potential short-term funding opportunities for establishing a music room, the GSA Board determined that, in the absence of long-term and sustainable funding for this project, we will not be moving forward with the proposal. The GSA will continue to receive updates from Kevin regarding potential funding opportunities to provide events that promote graduate student mental health.

The United Way launch event on October 11 was amazing and impressive. The GSA has been recognized as a great partner in the planning of the campaign event. Information regarding donations and donors can be found on the University of Alberta website. New posters have been printed and will be placed in various locations so that more people can learn about the campaign.

I have also been participating in meetings related to the PAW Centre to discuss various projects, including the replacement of cardio equipment in the fitness centre and the budget models for this project.

Furthermore, I attended the GSA Fall Engagement Event, where, as mentioned in Babak's report, there were games, food, and mingling. It was really wonderful and I hope attendees had fun and enjoyed themselves! I also attended a dinner with Studentcare representatives and a meet and greet with staff from the Faculty of Graduate Studies and Research – it was great to see many of the staff members who partnered with us on Departmental Orientations again. For the Green and Gold Pep Rally, although it was a cold day, the atmosphere was very exciting. The Faculty of Science, where my department is located, was judged the winner of the parade – congratulations to all involved!

Early Call for Talent and Training

GSA Bylaw and Policy states that "GSA NoC will be proactive in seeking out potential candidates for all Directly-Elected Officer (DEO) and Council-Elected Officer positions" (Section E: Nominating, GSA Policy, Nominating, Section E.POL.1.5). It also states that:

"The GSA NoC leads an annual initiative each October called the Early Call for Talent and Training. During Early Call, graduate students interested in running for elected office are invited to a get-to-know event and are encouraged to participate in a series of training sessions on such topics as University governance, GSA 101, budget and audit basics, collective bargaining, major GSA services, and more. Information is provided about the DEO portfolios and the time commitments involved. Information regarding the position for two (2) GSA Council members was circulated on two instances via email to GSA Council with a deadline of October 18, 2017. No nominations were received, so these vacancies will be advertised again. The one (1) position for a graduate student was advertised at least twice starting with the September 29, 2017 GSA newsletter with a nomination deadline of October 17, 2017. One (1) nomination was received. The nominee was then interviewed by GSA NoC Chair Radim Barta and GSA NoC Vice-Chair Kenzie Gordon, both of whom have been trained in procedural fairness by the GSA and have a record of demonstrating impartiality through their work on the GSA NoC. GSA Assistant Director Lisa Hareuther was also present. During the interview, the nominee was asked a series of questions aimed at assessing his awareness of the basic tenets of procedural fairness and his ability to adjudicate potential cases in accord with those tenets (note as well that all individuals elected to the GSA ACB receive training in procedural fairness). It should be noted that this nominee is also a nominee for the GSA ERC and as per GSA Bylaw and Policy, Section H: Performance, Conduct, Responsibilities, and Attendance, and the GSA Appeals and Complaints Board, GSA Policy, GSA Standing Committees, GSA Appeals and Complaints Board, Section H.POL.10.5, the graduate student has been informed that should he be elected for both positions, he would not be able to serve on both. There will be a paper ballot vote. See Item 7c – Nominees for GSA ACB.

4) GSA Awards Selection Committee (GSA ASC) (6 Graduate Student Positions)

These positions were advertised at least twice starting with the September 29, 2017 GSA newsletter with a nomination deadline of October 18, 2017. Eight (8) nominations were received. There will be a paper ballot vote. **See Item 7b – Nominees for GSA ASC.**

Below is a list of all the documents that define the GSA as a corporate entity. As a separate corporation from the University under the *Post-Secondary Learning Act*, we have our own infrastructure (we have our own, independent accountant and auditor, and serve as signatories to an array of agreements). Since last year when we presented this list to GSA Council, there are two important updates to the list. First, the GSA has now signed an agreement with the University of Alberta Information Services and Technology (IST) in June 2017 and, in accord with this agreement, IST is now supporting GSA's IT infrastructure. Second, following the successful U-Pass referendum in March 2017, a new U-Pass agreement is now in place for the next four years, expiring in August 2021.
