The meeting was called to order at 6:01 pm. Speaker acknowledged the Traditional Territory of Treaty Six.

5. Councillor Announcements

E Asiedu, GSA Councillor for Laboratory Medicine and Pathology, noted that the Canadian Coalition of Women in Engineering, Science, Trades, and Technology (CCWESTT) was holding their bi-annual conference from 30 May to 2 June and invited members to volunteer for this event.

O Bamforth, GSA Councillor for Religious Studies, invited graduate students to attend the Religious Studies Graduate Student Symposium on heroism and villainy in religion on 27 April and 28 April. He noted that it was an interdisciplinary symposium and that all were welcome to attend.

Presentation

6. Athletics and Recreation Presentation

B Soltannia (GSA President) presented the item and introduced the guests, Dr. Ian Reade (Director of Athletics) and Cheryl Harwardt (Director of Campus and Community Recreation). He noted that Athletics and Recreation last attended GSA council in May 2016 to present on what they do and how they are funded. He added that athletics and recreation was committed to attending GSA Council about once a year to discuss their services and how student mandatory non-instructional fees were used in this area, for the purposes of transparency and accountability.

C Harwardt began by outlining the principles that guide Athletics and Recreation: transparency, accountability, partnership, collaboration, and consultation. She noted that students paid approximately \$5.5 million in fees towards Athletics and Recreation, under the umbrella of Mandatory Non-Instructional Fees (MNIFs). She explained that Athletics and Recreation were separated into two branches: Athletics under Dr. Ian Reade and Campus & Community Recreation under Cheryl Harwardt.

C Harwardt noted that, for Campus & Community Recreation (CCR), the vision was to inspire and empower exceptional life experiences by facilitating and delivering leading-edge programs, events, and services. She also noted that CCR valued leadership, collaboration, kaizen, civility, and inclusiveness. She explained that they were funded by a U of A operating contribution of \$1.2 million, revenue generated from rentals, memberships, and program fees totaling \$3 million, and the Athletics and Recreation fees generated by the MNIFs paid by students totaling \$4.2 million. She added that this revenue was then put towards facility and programming employees' wages and general operating costs. She highlighted a few statistics of use of the different services they offered noting that, between January and December 2017, the fitness centre was used

490,870 times, the locker rooms were used 1,024,754 times, the climbing centre was used 25,000 times, the yoga mats were rolled out 29,187 times, and 1,000 individuals participated in kick-boxing every week.

I Reade presented on the Golden Bears and Pandas Athletics. He noted that there were 20 varsity teams at the University, also noting that the golf program had been eliminated in response to budgetary restrictions. He specified that varsity teams had approximately 5-10 graduate student athletes each. He outlined the Athletics budget which broke down to \$4.8 million in revenue generated through donors, sponsorships, event attendance, alumni, and U of A operating budget contribution, plus \$3.2 million generated via Athletics and Recreation fees and he noted that this budget was then put towards staff salaries, supplies, rentals, and teams travel. He added that Athletics granted \$1.5 million a year in scholarships to students. He concluded the presentation by inviting those present to the upcoming Sport Conference from May 31 to June 2. He specified that the conference was free for students with the use of promo code "ONECARD" when registering and explained that it was presented by U of A staff, students, and coaches, and would encompass discussions on the public good of the community, panel discussions, and more.

GSA Council members asked a series of questions concerning, among other issues, whether graduate student fees should be applied in larger part to CCR versus Athletics given that very few graduate students were involved in Athletics programs (I Reade noted the complexity of identifying the appropriate ratio in such a situation); whether the Athletics scholarships were only awarded to undergraduate students (I Reade responded that all students in Athletics programs were eligible, but inevitably more undergraduate students received them); how student fees supported facilities maintenance such as the floor getting replaced recently (C Harwardt noted that the flooring issue was primarily addressed by warranty and not standard operating budget lines); the plan for locker room renovations (C Harwardt outlined the plan which comprised multiple phases and was set to begin near the end of summer, the project was expected to take 18 months from start to finish and that the first phase was for the development of a gender neutral locker room, and then improvements to the men's and women's locker rooms would follow); whether the saunas in the locker room would be fix (C Harwardt responded that the saunas were to be taken out due to the high cost associated with their maintenance); and whether Athletics was projecting the elimination of more programs in the face of budget cuts (I Reade responded in the affirmative and noted that Athletics was hoping to work on increasing their alumni contributions prior to cutting additional programs; C Harwardt added that CCR would work to minimize their equipment maintenance costs in the face of budget cuts).

8. GSA Board 2017-2018 Strategic Work Plan: Final Update

B Soltannia presented the item and noted that the letter circulated to GSA Council provided the final update regarding the work of the 2017-2018 Directly-Elected Officers (DEOs) and the progress they had made on the GSA Board Strategic Work Plan (SWP), since their last update in January. He added that many of the goals in the SWP were long-term initiatives that spanned several years, so the 2018-2019 DEOs would consider these items when they began work on the next SWP. He noted that some key highlights updates and progress on their work to advocate for guaranteed minimum funding packages, conversations and advocacy related to tuition, continued work on collective agreement bargaining, submission of a proposal to allow scholarship holders to pay tuition in installments, the launching of a survey to collect data on the topic of the collection of Residence Association fees, continued participation in conversations about professional development opportunities and academic governance reforms, the hosting of a graduate student safety session, and participation in conversations regarding the development of University policies in response to the upcoming legalization of cannabis, and the future of Smart Fare for the City of Edmonton Transit System. Lastly, B Soltannia thanked his team and the GSA office staff for their hard work and support.

GSA Council members asked a series of questions concerning, among other matters, which initiatives the DEOs thought had not received sufficient attention and the emerging trends that they thought GSA Council and the next GSA Board should be aware of going forward (questions submitted via email) (DEOs highlighted their work on graduate supervision and conversations about the importance of establishing tools for evaluating faculty members as supervisors, the momentum created in the advocacy for minimum funding packages, the impact that University budget cuts may have on future projects, the initiation of the student parents housing research project, the introduction of new province-wide Occupational Health and Safety legislation which could create an opportunity for the establishment mandatory training for those who are supervising graduate students, the graduate student safety and security session that the GSA hosted in March, collective agreement bargaining, the recent joint statements with other University constituencies in response to the University's budget and increases to international tuition, and changes to academic governance such as the inclusion of more graduate students on University governance bodies and the importance of engaged graduate student representatives); a GSA Council member shared some issues they were currently facing in their graduate program (S van der Klein emphasized that the GSA was a safe space for graduate students who had any concerns or questions about a supervisor and noted that all questions, emails, and meetings were kept confidential and dealt with on a case-by-case basis; she also emphasized that this was also the case for graduate students who met with staff from the FGSR to discuss issues); whether the proposal to allow graduate students who received scholarships to pay their tuition in installments had been finalized (S van der Klein noted this had not been finalized yet and that the hope was that this model would parallel what was currently established for research and teaching assistants who can choose to have their tuition deducted from their salary in installments without interest or penalties); and the extensive security problems in the Fine Arts Building were discussed at length (including the gaps in communication from the Dean of Arts that occurred in some departments and the importance of communicating these concerns and taking a strong stance on these matters, the different situations in which University of Alberta Protective Services (UAPS) was unable to respond, miscommunication between 911 dispatch and UAPS during certain incidents, security models used at other universities, and an update was provided that the DEOs had continued to raise these issues with the Dean of Students and the Provost and that additional security guards and installation of more security cameras would be implemented in future months. It was also noted that a new Campuses and Facilities Safety and Security Working Group had been established in response to increased numbers of reports and incidents associated with safety and security issues).

In addition B Soltannia congratulated the recipients of the GSA Recognition Awards and expressed his gratitude towards the other DEOs, GSA office staff, members of GSA Board and the Alberta Graduate Provincial Advocacy Council (ab-GPAC), the Faculty of Graduate Studies and Research, and the Dean of Students for their hard work over the course of the previous year.

Outline of Issue

Proposed Changes to GSA Bylaw and Policy and Introduction of GSA Bylaw and Policy on Collective Bargaining

Suggested Motion for GSA Council:

That GSA Council, on the recommendation of the GSA Governance Committee and the GSA Board, **APPROVE** the proposed changes to GSA Bylaw and Policy and the introduction of GSA Bylaw and Policy on Collective Bargaining, as shown in the attached double column document and effective upon the second reading by GSA Council in the case of GSA Bylaw and the approval of GSA Council in the case of GSA Policy.

NOTE 1: The proposed changes apply to Section A: Authority, GSA Bylaw, Authority; Section D: GSA Officers, GSA Bylaw, GSA Officers and GSA Policy, GSA Officer Portfolio; and Section F: GSA Standing Committees, GSA Bylaw and Policy, GSA Standing Committees. This document also introduces the new Section Q: Collective Bargaining, GSA Bylaw, Collective Bargaining and GSA Policy, GSA Standing Committees, GSA Labour Relations Committee, and GSA Policy, GSA Negotiating Team.

NOTE 2: The is the first reading of proposed changes to GSA Bylaw, proposed changes to GSA Policy are presented for information. The second reading of proposed changes to GSA Bylaw and approval of proposed changes to GSA Policy will be presented at the June GSA Council meeting.

Background:

With the introduction of Bill 7, the GSA is required to comply with the *Labour Relations Code*. Under the *Labour Relation Code*, the GSA is now recognized as a "trade union" and the "bargaining agent" for academically-employed graduate students (Graduate Teaching Assistants, Graduate Research Assistants, and Graduate Research Assistant Fellowships).

In order to comply with the *Labour Relations Code*, GSA Bylaw and Policy need to be amended to include a section on collective bargaining and to amend various section to clearly indicate that the GSA acts in the interests of academically-employed graduate students in their role as a trade union. The amended GSA Bylaw and Policy are required to be submitted for approval by the Labour Relations Board before 1 July 2018.

The proposed changes to GSA Bylaw and Policy and introduction of GSA Bylaw and Policy on collective bargaining have been reviewed by the GSA's lawyers. This proposal has also been reviewed by the legal counsel of the Labour Relations Board and they do not foresee any concerns with the Labour Relations Board's approval of the amended GSA Bylaw and Policy as drafted.

The GSA Governance Committee reviewed and recommended the proposal to GSA Council at its 20 April 2018 meeting. The GSA Board discussed and reviewed the proposal at its meeting of 18 April 2018 and made their own motion to recommend the proposal to GSA Council at their 2 May 2018 meeting.

Outline of Issue

Proposed Changes to GSA Bylaw and Policy, GSA Bylaw, Section B: Membership

Suggested Motion for GSA Council:

That GSA Council, on the recommendation of the GSA Governance Committee and the GSA Board, **APPROVE** the proposed changes to GSA Bylaw and Policy, GSA Bylaw, Section B: Membership, as shown in the attached double column document and effective upon the second reading by GSA Council.

NOTE 1: The is the first reading of proposed changes to GSA Bylaw; the second reading of proposed changes to GSA Bylaw will be presented at the June GSA Council meeting.

Background:

The University Calendar (both current and from previous years) offers a series of conflicting statements about the graduate student status of postgraduate medical education (PGME) trainees, including:

2000/01 Calendar: "All postgraduate medical trainees are registered as graduate students in the Division of Postgraduate Medical Education if the Faculty of Medicine and Dentistry and pay a program registration fee" and "for classification purposes, postgraduate medical students are considered graduate students. As such, they have the option of paying fees to the Graduate Students' Association."

2006/07 Calendar: "Postgraduate medical students: For classification purposes postgraduate medical students are considered to be graduate students and they have the option of paying fees to the Graduate Students' Association."

2017/18 Calendar: "Postgraduate medical education (PGME) students have the option of paying fees to the Graduate Students' Association" and "all postgraduate medical trainees are registered as graduate students in the Division of Postgraduate Medical Education of the Faculty of Medicine and Dentistry and pay a program registration fee."

While they are only occasionally differentiated as a separate program, postgraduate dental education (PGDE) trainees are also included in the PGME category

Notwithstanding this, and however the University elects to define PGME/PDGEs for "classification purposes," they are not admitted to and registered in the Faculty of Graduate Studies and Research (FGSR) and are not pursuing a graduate program (indeed, the Undergraduate Enrollment Report for 2017-2018 clearly indicates that PGME/PGDE registrations, reporting, etc are overseen by the Office of the Registrar, rather than FGSR). Likewise, both University and GSA administrative practice, since the U-Pass program was created in 2007, has been to permit PGMEs and PGDEs access to the U-Pass only (and not to other GSA services) if they elected to pay the GSA membership fee (as a point of reference, in 2015-2016 there were 994 PGMEs registered and 77 of them elected to pay the GSA membership fee in order to access the U-Pass program; in 2017-2018 there were 1,100 PGMEs and PGDEs combined).

The proposed amendment to GSA Bylaw detailed in the attached double column document aligns the GSA's governing documents with this practice in order to provide greater clarity surrounding this category of GSA "membership," while also clarifying that GSA members are students admitted to and registered in FGSR (again, to align with well-established GSA practice). The GSA had previously secured a legal opinion on this matter and the proposed changes are in line with the provision detailed in that legal opinion that it is within the GSA's statutory authority under the *Post-Secondary Learning Act* to determine and the rights and privileges of its own members.

The GSA Governance Committee reviewed and recommended the proposal to GSA Council at its 20 April 2018 meeting. The GSA Board discussed and reviewed the proposal at its meeting of 18 April 2018 and made their own motion to recommend the proposal to GSA Council at their 2 May 2018 meeting.

Dear Valued Graduate Students, Fellow Councillors and Colleagues,

I hope you had a chance to enjoy the spring weather and sunshine after a successful exam period and that you are also ready to start a new semester full of energy and enthusiasm!

Following the approval of the 2018-2019 GSA budget at the February 2018 GSA Council meeting, I presented an item on the GSA's membership fees collection for 2018-2019 during the Board, Finance, and Property Committee (BFPC) meeting in mid-April. The Board of Governor's approval of collection of these fees, beginning in September 2018, will occur at their meeting in early May.

In late April (23 April), the Ministry of Advanced Education issued a letter to the University related to 2018-2019 funding, which confirmed a 2% increase to the Campus Alberta grant for the U of A, as well as providing for further funding to support the extension of the domestic tuition freeze. We hope this information provides enough certainty to allow the Board of Governors to revisit their decision about the budget.

In late April, I signed the four-year U-Pass contract, which was approved by graduate student referendum in March 2017. As you know, this agreement is a good deal for graduate students since it continues to save them money for accessing transit.

Regarding external advocacy, Masoud and I, as the ab-GPAC Vice-Chair, had the opportunity to participate in a lunch meeting with the Minister of Advanced Education, Honorable Marlin Schmidt, during which we continued to ask the government to act on their promises to support students, faculty, and staff. We emphasized our <u>stance</u> in a blog post with respect to our advocacy work against the fee increases. Additionally, as Sasha and Masoud Khademi outlined in their reports, ab-GPAC held its transition meeting on April 27-28 at the University of Alberta. Sasha, Zhihong, Masoud and I attended and it was an intensive, compact, and very informative meeting. During this meeting, Sasha was elected to serve as ab-GPAC Chair for the upcoming year. Based on the level of enthusiasm and the quality of questions the new representatives asked, I believe the organization is in good hands.

At the end of April, Sasha, Zhihong, and I attended the ThinkGRAD conference in Vancouver as observers. ThinkGRAD has replaced the previous GU15 group, which consisted of GSAs from the U15 universities (15 research intensive universities) across the country. This conference was a wonderful opportunity to see how other institutions tackle similar issues, and to bring additional experience and knowledge home. Moreover, this conference was a good networking opportunity, and a great place to make new connections and friends!

Again, I would like to share my feelings about being so lucky and fortunate to work with and for such incredible people! I am speechless, and I really don't know how to thank everyone enough. I am very grateful for the opportunity to serve my community, and I hope I and my team were able to ameliorate students' experiences on campus!

GSA Vice-President Academic Report to GSA Council for the 14 May 2018 Meeting

Dear Council Colleagues,

I hope that you are having a wonderful time while enjoying the sunny days of spring. As the 2017-2018 Vice-President Academic, I attended several meetings and was involved with various discussions during the last few days of my term in late April; I share the highlights with you in this report.

Update on the International English Language Testing System (IELTS) Requirement Discussion

As I already mentioned in my March report, the Faculty of Graduate Studies and Research (FGSR) has been looking at different options to increase the IELTS requirement for graduate program admissions. The last time this item came to the FGSR Council, there were some concerns about increasing the minimum band from 5 to 6 for some departments, as they thought this might significantly decrease the number of international students that could be admitted. Next, FGSR worked to collect data in order to ensure the FGSR Council could carefully consider this decision. Based on the data that FGSR recently received, from the 1385 offers in the current academic year of 2017-18, 839 applicants had taken IELTS. This means an impact of 2% to 16% among different departments and of course the number of individuals who may have been impacted if a higher minimum IELTS score had been in place at the time of their application varies based on the size of the department. More research needs to be done before this item goes back to the FGSR Council for discussion and approval in the fall.

Update on the Re-Examination Discussion

As you might remember, we had this discussion at GSA Council last summer, as to whether it would be possible to allow graduate students to re-take course exams and projects. I had already talked to the Dean of FGSR about this topic during the past year and it was supposed to be discussed at the FGSR Council Policy Review Committee (FGSR PRC). However, the FGSR PRC was unable to discuss matter due to other priorities on the committee's workplan. As a result, the incoming Interim FGSR Dean, Dr. Deborah Burshtyn, indicated that this item will be brought forward to the FGSR PRC in the fall.

Research Ethics

Just as a friendly reminder on research ethics for graduate students, we have seen students facing problems in their program due to not knowing the existing policies about research ethics. Students must familiarize themselves with these policies and the earlier this happens during their program, the less problems students may have along the way. You can learn more <u>here</u>.

I am so excited that our new team is on board now! I am quite sure that we will do our best to serve graduate students in the upcoming term. I am also very excited that spring has finally come and I wish you a wonderful warm season! I hope you enjoy the weather, as summer is so beautiful, and too short! Unfortunately, I am not able to attend the May council meeting as I will be on an academic leave this week to attend a conference in Toronto. I am impatiently looking forward to seeing you at the next GSA Council meeting!

During the past month, I attended several meetings, including my job-shadowing meetings prior to May 1 and my official meetings as GSA VP Academic from May 1 onward. I will share the highlights with you in this report.

Let me start with the ongoing project of **Libraries' Accessibility**, managed by U of A Library Administration. The goal of this project is to assess the accessibility of library resources, which will lead to suggestions, recommendations, and proposals to improve accessibility to different library resources. This includes both electronic and hardcopy resources. Some highlights about this project are:

- Some emotional and physical barriers that are already impacting the accessibility of the libraries have been found;
- More detailed maps and directory information would be beneficial; and
- Staff awareness and training assessments are also ongoing.

Another highlight includes an update on the **Libraries' Digital Scholarship Centre**. In case you don't know, the Centre will be located on the 2nd level of Cameron Library (2-10). A visualization wall, 3D printing/scanning, a carving virtual reality (VR) studio, tech-enabled collaboration areas, digital publishing, research data management and advanced desktop computing are services that will be provided in this Centre. The structure is supposed to be finalized by October 2018 and open by January 2019. **Please note that, some employment and internship opportunities will be available for graduate students**. Interestingly, there are not many similar centers in Canada, with only McMaster University and the University of Victoria having similar resources.

An update on the Student Success Centre is that its name has be changed to the Academic Success Centre. Individual consultation services and workshops will still be offered.

Another meeting I attended was the General Faculties Council Nominating Committee (GFC NC) in which we went through all applications to GFC committees from academic staff, non-academic staff, and students. The positions need to be filled by June 30. GFC NC and the GFC Replenishment Committee will have a joint meeting on June 4 for the replenishment of the 2018-19 GFC Executive and GFC Nominating Committees. Please **note** that the Council on Student Affairs (COSA) has one vacancy for one of the graduate members serving on the General Faculties Council for 2018-2019. There is a transition taking place in terms of COSA's mandate and future work which makes this position much more important.

Should you have any questions or comments about this report, please let me know and I will be more than happy to answer. Please do not hesitate to share your suggestions or concerns regarding any academic-related issue you or anyone from your department may have.

I hope you are doing well in every aspect of your lives and are enjoying the warm weather we have had in the past few days. Since this is my last report to GSA Council, I will try to keep it short and sweet.

One of the important meetings that Sasha, Zhihong, Babak, and I attended in the final days of my term was the ab-GPAC transition meeting (as others report). This year, the U of A GSA hosted this day long meeting, where outgoing and newly elected representatives from the member institutions came together at Triffo Hall to discuss the future direction of this organization. The outgoing ab-GPAC Chair, Willem Klumpenhouwer, also explained the role and mandate of this advocacy group to the new members. We also had a chance to discuss the importance of graduate students' representation in the decision-making process in Alberta. Finally, at the end of this meeting, we held the election for 2018-2019 executive roles. As Sasha has noted in her report, she was elected to serve as the ab-GPAC Chair for the upcoming year.

I hope this report finds you all well and enjoying the beautiful weather. I'm so excited to officially be in my new position as VP Labour, and first of all I'd like to thank the office team, outgoing Directly-Elected Officers (DEOs) and everyone who helped make the transition process as smooth as possible. There are three highlights of my work this month I would like to report on:

Campus Facilities Safety and Security Working Group

This specialist working group has been set up by the University Vice-President (Finance and Administration) and Vice-President (Facilities and Operations) in response to the safety and security issues reported on campus, and is headed by the Office of Risk Management. The group is meeting twice monthly and has members from all across campus, including representatives from facilities and parking services, the Non-Academic Staff Association (NASA), the Association of Academic Staff: University of Alberta (AASUA), the Students' Union (SU), the GSA, and University administrators. The aim of the group is to deliver a report with recommendations on improving campus safety and security to senior University Administration by September 1, 2018.

The terms of reference for this new working group are in the process of being finalised, and I will communicate them to the GSA membership as soon as they become available to me. In the meantime, please contact me directly if you have any concerns, comments or questions you would like me to bring to this working group.

Sexual Violence Prevention Advisory Committee and Steering Committee

In April, there was a meeting of the full Sexual Violence Prevention Advisory Committee, which has numerous stakeholders from all aspects of campus life. In this meeting, we were asked to identify issues that the University should consider as priorities for sexual violence prevention, which were then brought forward to the Steering Committee. Once again, if anyone has any concerns, comments or questions they would like me to bring to this committee, please let me know.

Collective Agreement Negotiations

Negotiations for a new Collective Agreement are ongoing. As discussed in my email, circulated on May 4, to academically-employed graduate students, the language regarding the agreement has been largely finalised and the outstanding issue is stipends. We have asked the University to provide some data on stipends to facilitate this discussion, and are awaiting their response.

I hope everyone is doing well, enjoying the spring and the warm weather. I am the new GSA Vice-President Student Services (VPSS), and I am fortunate and happy to start this new chapter in my life and serve as your VPSS and collaborate with you in the coming year. Before I start my report, I would like to take this chance to thank everyone who voted for me. I hope I meet your expectations and am looking forward hearing your comments, suggestions, concerns, and ideas so that I can serve the GSA and the graduate student body in the most effective way.

I started my term on May 1, 2018, and I was fortunate enough to have great support from the current and previous Directly-Elected Officers. Thank you, Royle Feng, for your help and assistance in making the transition smoother. I also want to thank the GSA management team and staff, who helped me learn about ongoing issues during the job shadowing period.

To learn more about my position before I officially started, I attended a few meetings during the job shadowing period:

Suicide Prevention Implementation Policy Subcommittee

I attended this meeting during job shadowing with Sasha, the previous GSA VP Labour and current GSA President. As one of my campaign goals is to increase mental health awareness and accessibility, sitting on this committee fits completely with my campaign goals. I am looking forward to being involved with this committee and will be working on other mental health projects and committees in the near future.

U-Pass Advisory Committee Meeting

GSA Associate Director Julie Tanguay and I attended the meeting where stakeholders from the Edmonton Transit Service (ETS), other municipal transit providers, and other Edmonton student associations were present. The meeting was informative and different parties provided updates on issues with potential impacts to student transit use. The main point of the meeting was a discussion on ETS's work to make the transit system more efficient. Old routes will basically all be gone, and new routes will be implemented (although some will be very similar to what currently exists). It was noted that there are four major pieces to the re-design: 1) bus routes on main roads, 2) express bus routes (going from point A to point B without stopping), 3) ring bus routes (avoiding the downtown core), and 4) neighbouring bus routes (which will circulate in neighbourhoods and connect with the above listed bus routes). ETS has designed a survey to get feedback on all of these proposed new bus routes, and you can access this survey <u>here</u>. I highly encourage you to do the survey and give your opinions about the new bus routes.

U-Pass Administration Committee

GSA Associate Director Julie Tanguay and I attended this meeting. Julie shared the results of the transit usage survey that a group of nursing practicum students distributed to all Michener Park residents earlier this year. There was a small number of participants (12) but the data indicated that the average length of commuting time between Michener Park and U of A campus is 78 minutes/day. As outlined in Masoud Khademi's final report to GSA Council as the outgoing GSA VP External, he shared the results of this survey during his meeting with Katherine Huising, Associate Vice-President (Facilities and Operations), Ancillary Services, and Janice Johnson, Assistant Dean of Students, Residences.

1) GSA Councillor-at-Large (1 Graduate Student Position)

There is one (1) GSA Councillor-at-Large vacancy remaining for a graduate student. Below are some highlights of what the office support team has been engaged with over the past month. I, and the other members of the team, am happy to answer questions and, as usual, the detailed reports submitted to the GSA Board are also attached below.

Fiscal Year End and Annual Audit

Our Accountant and our Financial Manager have finished the annual process of reconciling all our accounts following the official end of the GSA's fiscal year on March 31. They are also working to prepare for our annual audit, as required by the *Post-Secondary Learning Act* (once the audit is completed we submit the GSA's audited financial statements to the Board of Governors). The auditors will be in the office at the beginning of June and the audit itself will come forward to GSA Council in July; our auditor, Tom Gee, will be in attendance.

Directly-Elected Officer Transition and Board Strategic Work Plan Development

Incoming Directly-Elected Officers (DEOs) began job shadowing current team members in April and we also held a day-long transition session in April for current and incoming DEOs. This year we have added to our training package a series of 101 sessions for new DEOs (targeted by portfolio) and have delivered several of these sessions in May. We are also supporting the new team of DEOs as they begin the process of drafting the 2018-2019 GSA Board Strategic Work Plan.

GSA Agenda/Handbook

While the printing of the GSA Agenda/Handbook does not occur until August, we begin the process of designing it and selling advertising space (the ad revenue generated, by and large, determines the final number of agenda/handbooks printed) in May and June.

Orientations for New Councillors-at-Large

Last year we developed some orientation sessions for new Councillors-at-Large (CALs) (consisting of a review of the Standing Orders of GSA Council, a GSA 101, and an overview of GSA Council's annual work plan). We have provided a few training sessions so far this April and May for newly elected CALs. I'd like to remind members of GSA Council that if they want, at any time, to arrange for a 101 session (Budget 101, Health and Dental 101, GSA Services 101, Governance 101, or GSA 101), they are welcome to contact the office.

ThinkGRAD

As Sasha and Zhihong report, the GSA participated as an observer in the recently held ThinkGRAD conference. ThinkGRAD is a national group geared at information sharing and discussion of best practices between Canadian graduate students' associations and the GSA is considering potential future membership in the group. The GSA's Associate Director, Julie, accompanied Sasha and Zhihong to the conference in a support role.
